#### **ORDINANCE NUMBER 2024-030**

#### AN ORDINANCE OF THE CITY OF BLUE ISLAND, COOK COUNTY, ILLINOIS AUTHORIZING A FEE FOR VEHICLE REGISTRATION FOR MOTOR VEHICLES WITH C-TRUCK LICENSE PLATES

WHEREAS, the City of Blue Island, Cook County, Illinois (the "City") is a duly organized and existing City created under the provisions of the laws of the State of Illinois and operating under the provisions of the Illinois Municipal Code, and all laws amendatory thereof and supplementary thereto, with full powers to enact ordinances and adopt resolutions for the benefits of the residents of the City; and

**WHEREAS**. Title III, Chapter 39, Section 39.01 of the Blue Island, Illinois Code of Ordinances ("City Code") details the fees for vehicle stickers in the City of Blue Island based on the type of motor vehicle being registered; and

WHEREAS, the Mayor and Aldermen of the City desire to create a fee for vehicle registration for motor vehicles with a C-truck license plate; and

WHEREAS, the Mayor and Aldermen of the City find that the following amendment to Chapter 39 of the City Code is in the best interests of the health, safety and welfare of the City and its residents.

**NOW, THEREFORE, BE IT ORDAINED** by the Mayor and Aldermen of the City of Blue Island, Cook County, Illinois as follows:

**Section 1**. That the above recitals and legislative findings are found to be true and correct and are hereby incorporated herein and made a part hereof, as if fully set forth in their entirety.

Section 2. That the Mayor and City Aldermen find and determine that the adoption of this Ordinance is in the best interests of the City as well as in the best interests of the public.

**Section 3**. That Chapter 39 ("Fee and Fine Schedule") of Title III ("Administration") of the Code of Blue Island, Illinois is hereby amended by adding the underlined language as follows:

#### § 39.01 FEE AND FINE SCHEDULE

**Section 4.** If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any other provision of this Ordinance.

**Section 5**. All ordinances, resolutions, motions or orders in conflict with this Ordinance are hereby repealed to the extent of such conflict.

**Section 6**. This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
