#### ORDINANCE NUMBER 2024 -036

#### AN ORDINANCE OF THE CITY OF BLUE ISLAND, COOK COUNTY, ILLINOIS, AMENDING CHAPTER 75, "OVERWEIGHT AND OVERSIZED VEHICLES" OF THE CODE OF BLUE ISLAND, ILLINOIS

WHEREAS, the City of Blue Island, Cook County, Illinois (the "City") is a duly organized and existing City created under the provisions of the laws of the State of Illinois and operating under the provisions of the Illinois Municipal Code, and all laws amendatory thereof and supplementary thereto, with full powers to enact ordinances and adopt resolutions for the benefits of the residents of the City; and

**WHEREAS**, the Mayor and City Aldermen may from time to time amend the text of the City Code of Blue Island (the "Code") when it is determined to be in the best interests of the health, safety and welfare of the City and its residents; and

WHEREAS, the City currently regulates overweight and oversized vehicle traffic within the City; and

WHEREAS, the Mayor and City Aldermen desire to modify the Code to create permanent restrictions on overweight truck traffic on Division Street to protect the critical infrastructure at that location; and

WHEREAS, the Mayor and City Aldermen find that the following amendments to the Code of Blue Island, Illinois, as set forth herein, are in the best interests of the health, safety and welfare of the City and its residents.

**NOW, THEREFORE, BE IT ORDAINED** by the Mayor and City Aldermen of the City of Blue Island, Cook County, Illinois as follows:

Section 1. That the above recitals and legislative findings are found to be true and correct and are hereby incorporated herein and made a part hereof, as if fully set forth in their entirety.

Section 2. That the Mayor and City Aldermen find and determine that the adoption of this Ordinance is in the best interests of the City as well as in the best interests of the public.

Section 3. That Chapter 75 ("Overweight and Oversized Vehicles") of Title VII ("Traffic Code") of the Code of Blue Island, Illinois is hereby amended by deleting the stricken language and adding the underlined language as follows:

**Section 4.** If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any other provision of this Ordinance.

**Section 5**. All ordinances, resolutions, motions or orders in conflict with this Ordinance are hereby repealed to the extent of such conflict.

**Section 6**. This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.

#### § 75.08 Unlawful Operation of Vehicles

It shall be unlawful to operate any vehicle, on the streets hereinafter designated, of a gross weight greater than indicated:

(a) Division Street from 127<sup>th</sup> Street to Des Plaines Street, a limitation of 5 tons gross weight.
