ORDINANCE NUMBER 2024-040

AN ORDINANCE OF THE CITY OF BLUE ISLAND, COOK COUNTY, ILLINOIS AMENDING TITLE XI ("BUSINESS REGULATIONS") OF CHAPTER 111 ("ALCOHOLIC LIQUOR") OF THE CODE OF THE CITY OF BLUE ISLAND

WHEREAS, the City of Blue Island, Cook County, Illinois (the "City") is a duly organized and existing City created under the provisions of the laws of the State of Illinois and operating under the provisions of the Illinois Municipal Code, and all laws amendatory thereof and supplementary thereto, with full powers to enact ordinances and adopt resolutions for the benefits of the residents of the City; and

WHEREAS, the Mayor and City Aldermen may from time to time amend the text of the City Code of Blue Island (the "Code") when it is determined to be in the best interests of the health, safety and welfare of the City and its residents; and

WHEREAS, the Mayor and Aldermen of the City of Blue Island desire to modify the Code to related to liquor license classifications and hours of operation for liquor license establishments within the City; and

WHEREAS, the Mayor and Aldermen of the City find that the following amendments to the Code of Blue Island, Illinois, as set forth herein, are in the best interests of the health, safety and welfare of the City and its residents.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Aldermen of the City of Blue Island, Cook County, Illinois as follows:

- **Section 1**. That the above recitals and legislative findings are found to be true and correct and are hereby incorporated herein and made a part hereof, as if fully set forth in their entirety.
- **Section 2**. That the Mayor and Aldermen of the City find and determine that the adoption of this Ordinance is in the best interests of the City as well as in the best interests of the public.
- **Section 3**. That Section 26 ("Hours of Operation") of Chapter 111 ("Alcoholic Liquor") of Title XI ("Business Regulations") of the Code of Blue Island, Illinois is hereby amended by adding the underlined language to read, as follows:

§ 111.26 HOURS OF OPERATION

It shall be unlawful to sell, or offer for sale, at retail any alcoholic liquor in the city, between the hours of 2:00 a.m. and 6:00 a.m. on Monday through Thursday. Friday and Saturday the hours shall be 3:00 a.m. to 6:00 a.m. Sunday the hours shall be 3:00 a.m. and 12:00 p.m., except as provided herein. A class A-1, A-1V, A-2, A-2V and M license may sell or offer for sale at retail any alcoholic liquor in the city between the hours of 7:00 a.m. and 12:00 p.m. on Sunday, only with prior authorization from the Local Liquor Commissioner.

Section 4. That Section 58 ("License Classifications and Fees") of Chapter 111 ("Alcoholic Liquor") of Title XI ("Business Regulations") of the Code of Blue Island, Illinois is hereby amended by deleting the stricken language and adding the underlined language to read, as follows:

§ 111.58 LICENSE CLASSIFICATIONS AND FEES.

- (M) Limitation on total number of licenses.
 - (6) Class B licenses to be issued under this chapter shall not exceed two three;
- (N) Class N (Distillery) license shall be known as the craft distiller license. It shall authorize a distiller the manufacture of spirits by distillation in quantities not to exceed the number of gallons authorized for production each year by a craft distillery in the Liquor Control Act of 1934 (ILCS Act 235, Ch. 5, §§ 1-1 et seq.) and the storage of such spirits. A craft distiller license shall allow the licensee to sell to distributors and to non-licensees in accordance with the Liquor Control Act (or similar act) of the State of Illinois. The craft distiller license shall allow the licensee to offer spirits manufactured by the licensee on the premises specified in such license for sale by the glass on the premises and in packaged form at retail on the premises specified in such license for the use or consumption off the premises. A craft distiller license shall permit the licensee to conduct tastings of spirits for which remuneration may or may not be received. A single tasting of distilled spirits shall not exceed one-fourth of one ounce. No more than three tastings of distilled spirits shall be provided to any person on any day. It shall be unlawful for such licensee to offer tastings or sell alcoholic liquor for consumption on or off the premises between the hours of 1:00 a.m. and 6:00 a.m., except New Year's Day, in which case such tastings and sales shall not be made between the hours of 2:00 a.m. and 6:00 a.m. The license fee for a Class N license shall be \$1,200 per annum payable on January 1 of each year.

(N) (O) Time period. All licenses issued pursuant to this chapter shall be valid from the date of issuance, or in the case of renewals, from January 1 through the business night of December 31, including the morning hours of January 1, per the closing times as stated in the license, or as indicated on the license. A new or renewed license will be required in order for the licensed premises to commence operations on January 1 of the new year.

- (O) (P) Late fee. A late fee of 5% will be assessed each day an applicant fails to timely re-apply for its license after January 1 of the new year.
- (P) (Q) Refunds. No refund of any fee shall be made to any licensee.
- **Section 5.** If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any other provision of this Ordinance.
- **Section 6**. All ordinances, resolutions, motions or orders in conflict with this Ordinance are hereby repealed to the extent of such conflict.
- **Section 7**. This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
