#### ORDINANCE NUMBER 2024-041

AN ORDINANCE OF THE CITY OF BLUE ISLAND, COOK COUNTY, ILLINOIS AMENDING CHAPTER 77 "PARKING SCHEDULES" OF THE CODE OF ORDINANCES REGARDING DESIGNATED RESIDENTIAL PERMIT PARKING ONLY ZONE B-10 TO INCLUDE CLINTON AVENUE.

WHEREAS, the City of Blue Island, Cook County, Illinois (the "City") is a duly organized and existing City created under the provisions of the laws of the State of Illinois and operating under the provisions of the Illinois Municipal Code, and all laws amendatory thereof and supplementary thereto, with full powers to enact ordinances and adopt resolutions for the benefits of the residents of the City; and

**WHEREAS**, the Mayor and City Aldermen may from time to time amend the text of the City Code of Blue Island (the "Code") when it is determined to be in the best interests of the health, safety and welfare of the City and its residents; and

WHEREAS, the City currently regulates parking throughout the City; and

**WHEREAS**, the Mayor and City Aldermen desire to modify the Code and create efficient and effective systems for the regulation and enforcement of parking within the City; and

WHEREAS, the Mayor and City Aldermen find that the following amendments to the Code of Blue Island, Illinois, as set forth herein, are in the best interests of the health, safety and welfare of the City and its residents.

**WHEREAS**, the Mayor and City Aldermen find that the following Ordinance is in the best interests of the health, safety and welfare of the City and its residents.

**NOW, THEREFORE, BE IT ORDAINED** by the Mayor and City Aldermen of the City of Blue Island, Cook County, Illinois as follows:

- **Section 1**. That the above recitals and legislative findings are found to be true and correct and are hereby incorporated herein and made a part hereof, as if fully set forth in their entirety.
- **Section 2**. That the Mayor and City Aldermen find and determine that the adoption of this Ordinance is in the best interests of the City as well as in the best interests of the public.
- **Section 3**. That Schedule II ("*Residential Permit Parking*") of Chapter 77 ("*Parking Schedules*") of Title VII ("*Traffic Code*") of the Code of Blue Island, Cook County, Illinois is hereby amended by deleting the stricken language and adding the underlined language as follows:

#### SCHEDULE II. RESIDENTIAL PERMIT PARKING.

(A) The following locations are hereby designated Permit Parking Only Zone B-10. Appropriate signs shall be erected by Public Works Department on the streets designated below informing the public regarding the Residential Parking restrictions. Upon receipt of an application and appropriate proof of actual residence within the Residential Permit Parking Only Zone B-10, the City Clerk is hereby authorized to issue annual "Residential Parking Permit" decals to residents of the District whose principal place of residence is located in the district.

Street	Location
Francisco Avenue	East and <u>wW</u> est sides on 128th Street
Clinton Avenue	East and West sides on 128th Street

**Section 4.** If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any other provision of this Ordinance.

**Section 5**. All ordinances, resolutions, motions or orders in conflict with this Ordinance are hereby repealed to the extent of such conflict.

**Section 6**. This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
