**A RESOLUTION OF THE CITY OF BLUE ISLAND,
COOK COUNTY, ILLINOIS, TO AUTHORIZE AND APPROVE THE CITY'S
APPLICATION FOR THE CY2024-CY2025 ROCK SALT CONTRACT JOINT
PARTICIPATION AGREEMENT WITH CENTRAL MANAGEMENT SERVICES**

WHEREAS, the City of Blue Island, Cook County, Illinois (the "*City*") is a duly organized and existing City created under the provisions of the laws of the State of Illinois and operating under the provisions of the Illinois Municipal Code, and all laws amendatory thereof and supplementary thereto, with full powers to enact ordinances and adopt resolutions for the benefits of the residents of the City; and

WHEREAS, the City of Blue Island has the authority to contract and be contracted with pursuant to 65 ILCS 5/2-2-12; and

WHEREAS, the City has elected to submit an application to Central Management Services for the CY2024-2025 Rock Salt Contract Joint Participation Agreement for the purchase of road salt; and

WHEREAS, the Mayor and Aldermen of the City of Blue Island have considered and reviewed the Application for participation in the CY2024-2025 Rock Salt Contract Joint Participation Agreement.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and the Aldermen of the City of Blue Island, Cook County, Illinois as follows:

Section 1. That the above recitals and legislative findings are found to be true and correct and are hereby incorporated herein and made a part hereof, as if fully set forth in their entirety.

Section 2. That the City may submit an application to participate in the CY2024-2025

Rock Salt Contract Joint Participation Agreement. Once the application is submitted and approved, the City Attorney may review the terms of the Agreement relating to the purchase of road salt and if acceptable authorize the same.

Section 3. That the Mayor and City Administration is hereby authorized to sign the application and various forms contained therein, make all required submissions, and do all things necessary to complete the application for the Rock Salt Contract Joint Participation Agreement.

Section 4. If any section, paragraph, clause or provision of this Resolution shall be held invalid, the invalidity thereof shall not affect any other provision of this Resolution.

Section 5. All ordinances, resolutions, motions or orders in conflict with this Resolution are hereby repealed to the extent of such conflict.


Section 6. This Resolution shall be in full force and effect immediately upon its passage, approval, and publication as required by law.


