A RESOLUTION OF THE CITY OF BLUE ISLAND, COOK COUNTY, ILLINOIS, AWARDING THE BID TO THE LOWEST RESPONSIVE AND RESPONSIBLE BIDDER, H&H ELECTRIC COMPANY, FOR THE WESTERN AVENUE LED CONVERSION PROJECT

WHEREAS, the City of Blue Island, Cook County, Illinois (the "City") is a duly organized and existing City created under the provisions of the laws of the State of Illinois and operating under the provisions of the Illinois Municipal Code, and all laws amendatory thereof and supplementary thereto, with full powers to enact ordinances and adopt resolutions for the benefits of the residents of the City; and

WHEREAS, the City is upgrading its lighting to new, brighter, energy efficient LED bulbs and heads on Western Avenue (the "Work"); and

WHEREAS, the City, by and through Christopher B. Burke Engineering, Ltd., sought bids from qualified companies to perform the Work; and

WHEREAS, Christopher B. Burke Engineering, Ltd., collected competitive bids for the Work and presented a recommendation to award the bid to the lowest responsible bidder as identified in the recommendation letter from Christopher B. Burke Engineering, Ltd. (the "Recommendation"), a copy of which is attached hereto and made a part hereof as Exhibit A; and

WHEREAS, the bid proposal from H&H Electric Company in the amount of \$37,797.77 was deemed to be the lowest responsible bid; and

WHEREAS, the City desires to award the contract for the Work to H&H Electric Company pending successful negotiations for a contract or agreement to perform the Work for the City; and WHEREAS, The Mayor and Aldermen of the City deem it advisable and in the best interest

of the health, safety and welfare of the residents of the City to accept the bid from DH&H Electric

Company in the amount of \$37,797.77 and award the contract for the Work to H&H Electric Company pending successful negotiations for a contract or agreement to perform the Work for the City.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and the Aldermen of the City of Blue Island, Cook County, Illinois as follows:

Section 1. That the above recitals and legislative findings are found to be true and correct and are hereby incorporated herein and made a part hereof, as if fully set forth in their entirety.

Section 2. That the purpose of this Resolution is to accept the bid from and award the bid to H&H Electric Company pending successful negotiations for a contract or agreement to perform the Work for the City, as identified in the Recommendation, a copy of which is attached hereto and made a part hereof as Exhibit A.

Section 3. The bid is hereby accepted and awarded to H&H Electric Company in the amount of \$37,797.77 pending successful negotiations for a contract or agreement to perform the Work for the City.

Section 4. The Mayor and Aldermen of the City of Blue Island hereby authorize and direct the Mayor or his designee and the City Attorney to negotiate a contract or agreement with H&H Electric Company. The Mayor and Aldermen of the City of Blue Island further authorize the Mayor or his designee to execute any and all additional documentation that may be necessary to carry out the intent of this Resolution. The City Clerk is hereby authorized and directed to attest to and countersign any documentation as may be necessary to carry out and effectuate the purpose of this Resolution. The officers, employees and/or agents of the City shall take all action necessary or reasonably required to carry out and give effect to this Resolution and shall take all action

necessary in conformity therewith. The City Clerk is also authorized and directed to affix the Seal of the City to such documentation as is deemed necessary.

Section 5. If any section, paragraph, clause or provision of this Resolution shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this Resolution.

Section 6. All ordinances, resolutions, motions or orders in conflict with this Resolution are hereby repealed to the extent of such conflict.

Section 7. This Resolution shall be in full force and effect upon its passage, approval and publication as provided by law.
