**A RESOLUTION OF THE CITY OF BLUE ISLAND,
COOK COUNTY, ILLINOIS, TO APPROVE UTILIZATION OF MFT FUNDS FOR THE
IMPROVEMENT OF STREETS/ROADS/STRUCTURES UNDER THE ILLINOIS
HIGHWAY CODE**

WHEREAS, the City of Blue Island, Cook County, Illinois (the “*City*”) is a duly organized and existing City created under the provisions of the laws of the State of Illinois and operating under the provisions of the Illinois Municipal Code, and all laws amendatory thereof and supplementary thereto, with full powers to enact ordinances and adopt resolutions for the benefits of the residents of the City; and

WHEREAS, Mayor and Aldermen of the City deem it necessary to improve certain streets within the municipality pursuant to the Illinois Highway Code;

WHEREAS, the proposed improvement shall consist of design engineering, construction engineering, and construction of street improvements consisting of HMA surface removal, pavement patching, HMA surface and binder course, driveway R&R, sidewalk R&R, curb and gutter R&R, parkway restoration and other miscellaneous items of work;

WHEREAS, the Mayor and Aldermen of the City have deemed it in the best interest of the City to utilize MFT Funds to finance this project, as described in **Exhibit A** attached hereto.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and the Aldermen of the City of Blue Island, Cook County, Illinois as follows:

Section 1. That the above recitals and legislative findings are found to be true and correct and are hereby incorporated herein and made a part hereof, as if fully set forth in their entirety.

Section 2. The City is hereby authorized and directed to utilize MFT Funds for the

improvement of streets/roads/structures as delineated in **Exhibit A** attached hereto.

Section 3. The officials and officers of the City are hereby authorized to undertake actions on the part of the City to complete the process described herein.

Section 4. If any section, paragraph, clause or provision of this Resolution shall be held invalid, the invalidity thereof shall not affect any other provision of this Resolution.

Section 5. All ordinances, resolutions, motions or orders in conflict with this Resolution are hereby repealed to the extent of such conflict.

Section 6. This Resolution shall be in full force and effect immediately upon its passage, approval, and publication as required by law.


