**AN ORDINANCE OF THE CITY OF BLUE ISLAND, COOK COUNTY, ILLINOIS,
AMENDING THE NAME OF REDEVELOPMENT PROJECT AREA, TIF 5, TO
UPTOWN TIF**

WHEREAS, the City of Blue Island, Cook County, Illinois (the "*City*") is a duly organized and existing City created under the provisions of the laws of the State of Illinois and operating under the provisions of the Illinois Municipal Code, and all laws amendatory thereof and supplementary thereto, with full powers to enact ordinances and adopt resolutions for the benefits of the residents of the City; and

WHEREAS, the "Tax Increment Allocation Redevelopment Act", 65 ILCS 5/11-74.4-1 et. seq., as amended (hereinafter referred to as the "Act") provides for municipalities to create within their corporate boundaries tax increment financing redevelopment areas; and

WHEREAS, pursuant to Section 11-74.4-4.2 of the Act the City approved Ordinance No. 08-037 on November 25, 2008, authorizing the establishment of a Tax Increment Financing "Interested Parties Registry," and adopted Registration Rules with regard to such Registry for TIF 5; and

WHEREAS, on November 25, 2008, the City approved the Redevelopment Plan and Projects, designated the Redevelopment Project Area and adopted Tax Increment Allocation Financing for TIF 5 pursuant to the Act; and

WHEREAS, pursuant to Section 11-74.4-5(c) of the TIF Act, after a municipality has by ordinance approved a redevelopment plan and designated a redevelopment project area, the plan may be amended as provided; and

WHEREAS, pursuant to Section 11-74.4-5(c) of the TIF Act, the City wishes to change the name of TIF 5 to Uptown TIF to eliminate confusion, improve marketing, provide a

reference to geographic location, and better align the naming conventions to the City's visions and goals for its TIF districts; and

WHEREAS, pursuant to Section 11-74.4-5(c), the Mayor and City Alderman find a change to the name of the TIF District does not: (1) add additional parcels of property to the proposed redevelopment project area, (2) substantially affect the general land uses proposed in the redevelopment plan, (3) substantially change the nature of the redevelopment project, (4) increase the total estimated redevelopment project cost set out in the redevelopment plan by more than 5% after adjustment for inflation from the date the plan was adopted, (5) add additional redevelopment project costs to the itemized list of redevelopment project costs set out in the redevelopment plan, or (6) increase the number of inhabited residential units to be displaced from the redevelopment project area, as measured from the time of creation of the redevelopment project area, to a total of more than 10. Therefore, no public hearing is required in relation to the same; and

WHEREAS, the Mayor and City Aldermen find that amending the name of TIF 5 to Uptown TIF is in the best interests of the health, safety and welfare of the City and its residents.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Aldermen of the City of Blue Island, Cook County, Illinois as follows:

Section 1. That the above recitals and legislative findings are found to be true and correct and are hereby incorporated herein and made a part hereof, as if fully set forth in their entirety.

Section 2. That the Mayor and City Aldermen find and determine that the adoption of this Ordinance is in the best interests of the City as well as in the best interests of the public.

Section 3. Pursuant to Section 11-74.4-5(c), this amendment may may be made without further public hearing and related notices and procedures including the convening of a joint review board as set forth in Section 11-74.4-6 of this Act.

Section 4. The City will give notice of this Ordinance and the amendment of the TIF name by mail to each affected taxing district and registrant on the interested parties registry, provided for under Section 11-74.4-4.2, and by publication in a newspaper of general circulation within the affected taxing district. Such notice by mail and by publication will occur not later than 10 days following the adoption by ordinance of such changes.

Section 5. If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any other provision of this Ordinance.

Section 6. All ordinances, resolutions, motions or orders in conflict with this Ordinance are hereby repealed to the extent of such conflict.

Section 7. This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
