A RESOLUTION OF THE CITY OF BLUE ISLAND, COOK COUNTY, ILLINOIS, AUTHORIZING A REQUEST FOR PROPOSALS FOR THE SALE AND DISPOSITION OF CITY-OWNED PROPERTY AT 2133 136th STREET

WHEREAS, the City of Blue Island, Cook County, Illinois (the "City") is a duly organized and existing City created under the provisions of the laws of the State of Illinois and operating under the provisions of the Illinois Municipal Code, and all laws amendatory thereof and supplementary thereto, with full powers to enact ordinances and adopt resolutions for the benefits of the residents of the City; and

WHEREAS, the City is the record-title owner of the property (the "Property") commonly known as the addresses listed below and as legally described in Exhibit A:

1. 2133 136th Street.

WHEREAS, Section 11-76-1 through 11-76-3 of the Illinois Municipal Code set forth the statutory process for the sale of municipal owned real property through competitive bidding; and

WHEREAS, the Mayor and Aldermen of the City find that the Property is no longer necessary, appropriate, required for the use of, profitable to, or for the best interest of the City; and

WHEREAS, the Mayor and Aldermen of the City have deemed it in the best interest of the City to dispose of the Property pursuant to Section 11-76-1 through Section 11-76-3 of the Illinois Municipal Code.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and the Aldermen of the City of Blue Island, Cook County, Illinois as follows:

Section 1. That the above recitals and legislative findings are found to be true and correct and are hereby incorporated herein and made a part hereof, as if fully set forth in their entirety.

- **Section 2.** The City is hereby authorized and directed to prepare and issue Bid Notices, in compliance with Section 11-76-2 of the Illinois Municipal Code, for the disposition of Properties.
- **Section 3**. The officials and officers of the City are hereby authorized to undertake actions on the part of the City to complete the process described herein.
- **Section 4**. If any section, paragraph, clause or provision of this Resolution shall be held invalid, the invalidity thereof shall not affect any other provision of this Resolution.
- **Section 5**. All ordinances, resolutions, motions or orders in conflict with this Resolution are hereby repealed to the extent of such conflict.
- **Section 6**. This Resolution shall be in full force and effect immediately upon its passage, approval, and publication as required by law.

RELEASE OF ALL CLAIMS

KNOWN ALL MEN BY THESE PRESENTS, that SHANNON ROWAN for the sole consideration of the total amount of Thirty Thousand Dollars and 00/100 (\$30,000.00) to her in hand paid, receipt of which is hereby acknowledged, has remised, released, and forever discharged and for her heirs, executors, administrators, and assigns, does hereby remise, release and forever discharge CITY OF BLUE ISLAND, BENNETT SCOTT, and their heirs, executors, administrators, shareholders, directors, officers, agents, insurers, successors, assigns, and all other parties, from any claims, demands, rights and causes of action of whatsoever kind and nature, which she may have, heretofore may have had, or may ever have relating or arising directly or indirectly from an incident at or near 107th Street and Kedzie Avenue in the City of Chicago, County of Cook, State of Illinois, allegedly occurring on or about May 7, 2023, and which is the subject matter of the above entitled cause of action being Case No. 2023 L 011340 in the Circuit Court of Cook County, Illinois.

It is further understood and agreed that this settlement is a compromise of a doubtful and disputed claim, and that the payment is not to be construed as an admission of liability on the part

of CITY OF BLUE ISLAND and BENNETT SCOTT by whom liability has been and is expressly denied.

SHANNON ROWAN warrants that no promise or inducement has been offered other than that which is stated herein, and that this release is executed without reliance upon any statement or representation by the person or parties released or their representatives concerning the nature and extent of the damages and liabilities, therefore.

SHANNON ROWAN further agrees as additional consideration of this settlement, that this release shall apply to all unknown damages resulting from said incidents, or events as well as those now known, and also releases all claims against CITY OF BLUE ISLAND and BENNETT SCOTT which might arise in the future.

It is further agreed as additional consideration for said payment and settlement of this claim, that SHANNON ROWAN shall indemnify CITY OF BLUE ISLAND and BENNETT SCOTT and their attorneys from all claims, demands, causes of actions, or suits of any kind as a result of any and all liens relative to repairs, legal, or medical expenses, or liens of any kind whatsoever relating to or deriving from the occurrence or consequences thereof described in plaintiff's complaint.

In consideration of the amount paid pursuant to this agreement, the undersigned, SHANNON ROWAN, agrees to defend, protect, indemnify, and hold harmless CITY OF BLUE ISLAND and BENNETT SCOTT against any and all liens, medical liens, physicians' liens, liens or claims by Medicare, Centers for Medicare and Medicaid Services ("CMS") and/or Medicaid, liens or claims by the Department of Public Aid and any other claims, including cross-claims and counterclaims or other causes of action of any type or kind that may hereafter be asserted or attempted to be asserted by anyone arising out of or relating to the matters alleged in the Complaint

filed in the above-referenced matter, whether or not such claims or liens are brought as part of the above-captioned proceeding. It is further understood and agreed that the obligations set forth above in this paragraph shall include the duty of the undersigned to pay or satisfy any and all damages and judgments which might be entered against CITY OF BLUE ISLAND and BENNETT SCOTT and costs of defending any such claims including, but not limited to, out-of-pocket fees.

SHANNON ROWAN hereby represents and states that she has carefully read the foregoing release of all claims, has had the advice of her attorneys concerning the same, and knows the contents thereof and signs the same as her own free act.
