A Blue Island homeowner wants alderman and department heads to hold property managers and owners responsible for the inside and outside maintenance of buildings, such as exit signs and fire extinguishers. She complained regarding the state of her building and the lack of follow-up by the City.

Blue Island resident demanded that building code issues be handled uniformly throughout the City, without preference to the historical district. She indicated that follow up is required by the building department for her apartment, as her heater/air conditioner should be on the wall rather than the floor.

7) New Business

a. 119th & Vincennes Development Proposal

Mr. John Mirkovic a former Deputy Clerk at the Cook County Clerk's Office, presented a proposal to the City Council regarding the City hosting a Cook County State Fair on the property at 119th & Vincennes. He proposed a private/public partnership with the City, that would have a three-person board governing the project and a private contractor managing the day-to-day operations. The City would receive 75% of the revenue from the event, a portion of which would be used to redevelop the land for future county fairs. The event would be a traditional county fair with rides and live entertainment, as well as a large-scale science and technology exhibits to keep everyone interested. The fair would be family-friendly and affordable for everyone. Sponsorships would come from governmental agencies and large corporations.

Alderman Roll said he loved the idea but wondered whether the focus would be on agriculture today or agriculture in general. Mr. Mirkovic indicated the County Fair will focus on general agriculture, including present-day farming and agriculture within Cook County.

Alderman McGee liked the idea, but noted his concerns regarding the environmental issues at the Property.

Alderman Johnson questioned what company would be managing the County Fair and inquired as to how much money would be invested into the project. He also inquired regarding security. Mr. Mirkovic claimed that he will do whatever is necessary and that he presently has over six figures if needed, with the goal of obtaining a million or two million grant monies to fund the project. He stated that it was critical to act promptly, to secure sponsorships for an October 2025 event.

Alderman Carr questioned the length of the County Fair.
